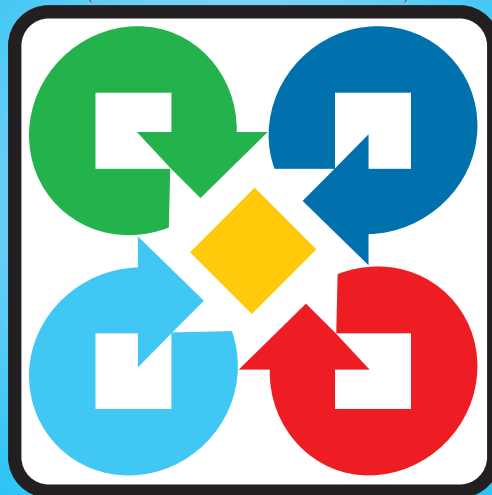

Disposal Station No. 1

Siam Waste Management Consultant Co., Ltd. has a joint cooperation with Siam Cement PLC. in industrial waste disposal at the main cement kiln of Siam Cement Group in Kaeng Khoi , Saraburi. The company has registered with Department of Industrial Works for being the conformed operator of industrial waste disposal service provider (Industrial type 101). The industrial waste to be incinerated at this facility must conform to standard characteristic for being used as substitute energy in the cement kiln.

Capacity

The disposal of industrial waste by incinerating in the cement kiln is considered the best method for the moment. Siam Cement PLC. has the highest capacity in providing cement kilns up to 5 locations in the country :

- Ta Luang Facility, Saraburi
- Khao Wong Facility, Saraburi
- Kaeng Khoi Facility, Saraburi
- Lampang Facility, Lampang
- Thung Song Facility, Nakorn Srithammarat

The certificate of industrial waste disposal facility type 101 was issued at Kaeng Khoi Facility while the others are allowed as temporary facilities

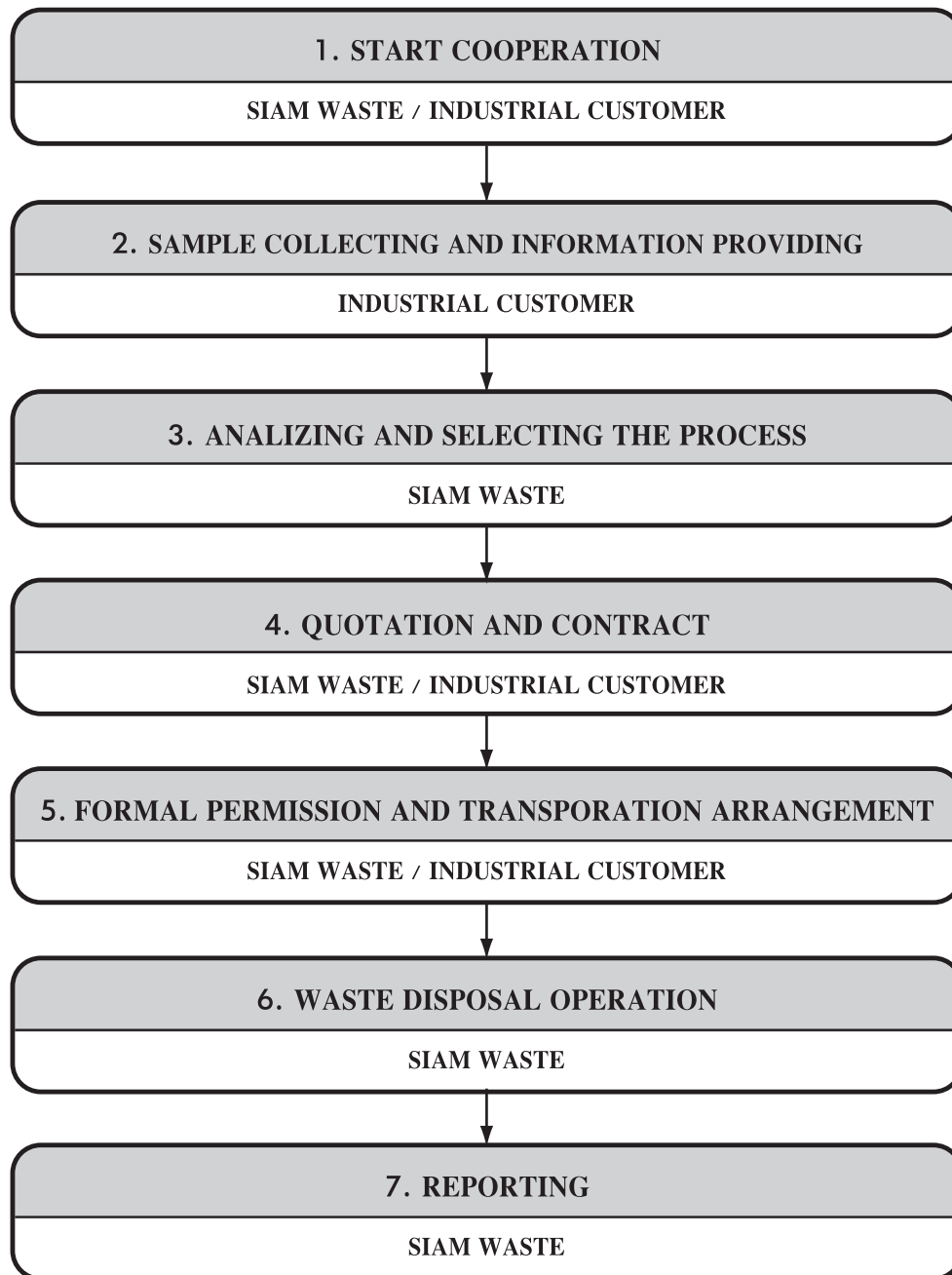

INDUSTRIAL WASTE DISPOSAL OPERATING PROCESS

1. START COOPERATION

Technical Sales Assistant contacts the customer and provides standard information form for customer to fill in. The information to be provided by customer shall include :

- Preliminary Industrial Waste Data Form 3 pages
- List of refuses to be disposed of 2 pages

2. SAMPLE COLLECTING AND INFORMATION PROVIDING

After the Data Form has been filled in with certified signature please return the Form to the Technical Sales Representative of Siam Waste Management Consultant. Please also attach the detail map of the location for industrial waste collecting. Then the company will make an appointment and arrange for collecting waste sample with detail as the followings.

- For solid industrial waste : Required weight of 3 Kg.
in completely sealed plastic bag.
- For liquid industrial waste : Required volume of 5 Litre
in completely sealed container.

Note All samples must have information sheet stating customer's name and type of waste attached to the packages.

3. ANALYZING AND SELECTING THE PROCESS

Siam Waste Management Consultant Co., Ltd. will normally charge the service fee for analyzing and selecting the waste disposal process. The company will confirm and clearly state the items to be analyzed and inform the service fee to the customer in advance.

4. QUOTATION AND CONTRACT

Quotation and Service Contract will be issued to the customer after the sample analysis has been completed. The customer shall provide the following documents for signing contract :

1. Factory Operation License
2. Certificate of Company Registration
3. Certificate of Value Added Tax Registration
4. Power of Attorney

5 FORMAL PERMISSION AND TRANSPORTATION ARRANGEMENT
